#### Personal data

Personal data is any information relating to an identified or identifiable person (data subject). An identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

## Data when accessing the website

If you only use this website to obtain information and do not provide any data, we only process the data required to display the website on the internet-enabled device you are using. This is in particular

- IP address
- Date and time of the request
- Amount of data transferred in each case
- The website from which the request comes
- Browser type and browser version
- Operating system

The legal basis for the processing of this data is legitimate interests in accordance with Art. 6 para. 1 lit. f) GDPR in order to enable the presentation of the website in principle.

In addition, you can use various services on the website for which further personal and non-personal data is processed.

## Your rights

As a data subject, you have the following rights

- You have a right of access to the personal data concerning you that is processed by the controller (Art. 15 GDPR)
- You have the right to rectification of the data concerning you if it is stored incorrectly or incompletely (Art. 16 GDPR)
- You have the right to erasure (Art. 17 GDPR)
- You have the right to request the restriction of the processing of your personal data (Art. 18 GDPR)
- You have the right to data portability (Art. 20 GDPR)
- You have the right to object to the processing of personal data concerning you (Art. 21 GDPR)
- You have the right not to be subject to a decision based solely on automated processing, including profiling, which produces legal effects concerning you or similarly significantly affects you (Art. 22 GDPR)
- You have the right to lodge a complaint with the competent supervisory authority in the event of a suspected breach of data protection law (Art. 77 GDPR). The supervisory authority at your usual place of residence, workplace or at the place of the suspected infringement is responsible.

## Use of cookies

Cookies may be stored on your device when you visit the website. Cookies are small text files that are stored by the browser you use. Cookies cannot execute programs or transmit viruses to your device. However, the place that sets the cookie can receive certain information about it. In particular, cookies can be used to recognize the device with which this website was accessed when it is accessed again.

The browser settings can be used to restrict or prevent the setting of cookies. For example, only the acceptance of cookies from third-party providers can be blocked or the acceptance of all cookies can be blocked. However, blocking cookies may mean that you can no longer use all the functions of this website. #### Matomo

Matomo is an analysis tool for the website that determines how often and on which page visitors move at what time and how long they stay there. Matomo collects personal data for storage and administration. This data is passed on to Matomo. The IPs are anonymized. An order processing contract has been concluded with Matomo. You can object to the collection of data at any time.

## **Privacy policy Google Analytics**
